5. Chairman's report WR  
Will Roberts reported on previous activities. It was noted that covid restrictions continued to have an impact and the diary had been light as a result.  
WR thanked all council members for their work, along with former Secretary Andrew Maxwell for his 4 years on the council, and Trevor Mathew-Jones who is stepping down as Treasurer and who has been a member of the Council since 2004.
6. Treasurer's report TMJ
  - i. To receive & adopt the OBS Accounts for y/e 31<sup>st</sup> December 2021 –
  - ii. To appoint an Independent Examiner (DSG)TMJ gave a precis of his time as Treasurer, starting in September 2004. He noted the 2001 accounts are very similar to 2020 and 2021, which can be considered healthy. The value of assets are £900,000 higher than 18 years ago, and he considers the current finances to be a good firm foundation to move forward in the future. TMJ noted a considerable donation from Graham Hurton (OB, OBS Council Chair and Chair of Governors) in 2016 when he passed away and recorded 'We do remember you, Graham, and we are very grateful'.  
TMJ remarked that he was happy to hand over to Rob Young, and wished him luck.  
WR thanked TMJ for his work and expressed that he will be missed.

PRV informed the AGM of the School's successful ISI Inspection, achieving the best exam results on the Wirral, and how the majority of leavers obtained their first choice university, along with some obtaining high-level apprenticeships. School numbers are 960 – the biggest the School has been for a while, enabling a far more selective approach for academics and standards.

On-site, School now has a refurbished library and meeting room block.

School are running a 'Be Inspired' programme for local children in Year 5 to attend on Saturdays in the summer, in the hope that this may identify some students to access the bursary programme.
